Any applications regarding **projects** must provide the following details:

- Objective(s) of the project
- Planned actions or activities
- Budget and contributions by applying organisation
- Your organisation's funder(s) and its/their financial situation
- Co-funding organisation(s) (if applicable)

Any applications regarding training and/or further education must provide the following details:

- Objective(s)
- Type, duration and location
- Organiser
- Cost and applicant's own contributions
- Co-funding organisation(s) and/or individual(s) (if applicable)

Any applications regarding **general integration activities or work** must provide the following details:

- Your organisation's funder(s) and its/their financial situation
- Objective(s) of activities/work
- Activities
- Co-funding organisation(s) (if applicable)

### What is this?

«Just as a body, though one,
has many parts, but all its many parts
form one body, so it is with Christ.»

1. Cor. 12,12

Today many people from diverse cultural, national and religious backgrounds live together in Switzerland. Many of them are Christian immigrants, who meet in so-called migrant churches. These churches and their members are also part of the reformatory family.

Being church together is a challenge and an opportunity – both for the local and for immigrant Christians. We require respect of and consideration for each other. We also need to engage in joint activities and give each other support.

The Reformed Churches of Bern-Jura-Solothurn took an important step in this direction in 2009 by clarifying their position in regard to migrant churches, which they defined as a new ecumenical relationship. In particular, cooperation is to be strengthened with so-called «new migrant churches» that have arisen from migrant movements in the past twenty years.

An important instrument towards achieving this is a contribution from the Reformed Churches of Bern-Jura-Solothurn of CHF 30 000.— for each year from 2011 to 2014.

## Who may apply?

Migrant churches, parishes and individuals from the catchment area of the Reformed Churches of Bern-Jura-Solothurn.





## What project(s) may receive funding?

Applications received from the following institutions and individuals will be submitted to an assessment:

- Integration projects and initiatives initiated by migrant churches
- Projects and initiatives to facilitate and/or promote encounters and contacts between Reformed parishes and migrant churches
- Training and/or further education of migrant church members in leadership positions
- Support of general integration work and activities provided by migrant churches

Any project to further encounters or integration may obtain funding on no more than two occasions. General integration work and activities provided by any migrant church, as well as training and/or further education for migrant church members in leadership positions may obtain funding on several occasions.
